DECLARATION OF FLUORINATED GAS PURCHASE (F-GAS)

With reference to the Regulation (EU) No. 517/2014 dated 16th April 2014, Art. 6 - point 3, concerning the Fluorinated Greenhouse Gases, which asking to operators to verify that purchasers of F-Gases are in possession of the relevant certificates, we kindly ask you to fill out the questionnaire here below and return it to the address countersigned by us.

Art. 6 – Record keeping – point 3

3. For the purpose of Article 11, paragraph 4, undertakings supplying fluorinated greenhouse gases shall establish records of relevant information on the purchasers of fluorinated greenhouse gases including the following details:

- (a) the numbers of certificates of the purchasers; and
(b) the respective quantities of fluorinated greenhouse gases purchased.

The undertakings supplying fluorinated greenhouse gases shall maintain those records for at least five years.

The undertakings supplying fluorinated greenhouse gases shall make such records available, on request, to the competent authority of the Member State concerned or to the Commission. To the extent that the records contain environmental information, Directive 2003/4/EC or Regulation (EC) No 1367/2006 shall apply as appropriate.
